## September to Present



- Last update to staff and Directors together was provided on September 23, 2020
- September 29, 2020: WLWB approves some changes to 2020 open water season only
- October 9, 2020: The Surety Bond Issuers and Washington at an impasse in negotiations. Unable to complete the transaction contemplated by the “Stalking Horse Bid”.
- October 30, 2020: Court approves extension under CCAA until December 15, 2020
- November 13, 2020: Company to recall approximately 60 furloughed employees effective early December, 2020 in order to prepare for an anticipated restart of the Ekati Mine.
- At this time, Dominion has been informed by the banks that comprise its senior secured lenders and an ad hoc group of holders of Dominion's second lien notes that they expect to be able to reach a binding agreement in the near future to restructure Dominion's debt and fund the Company.

## Next steps for Ekati

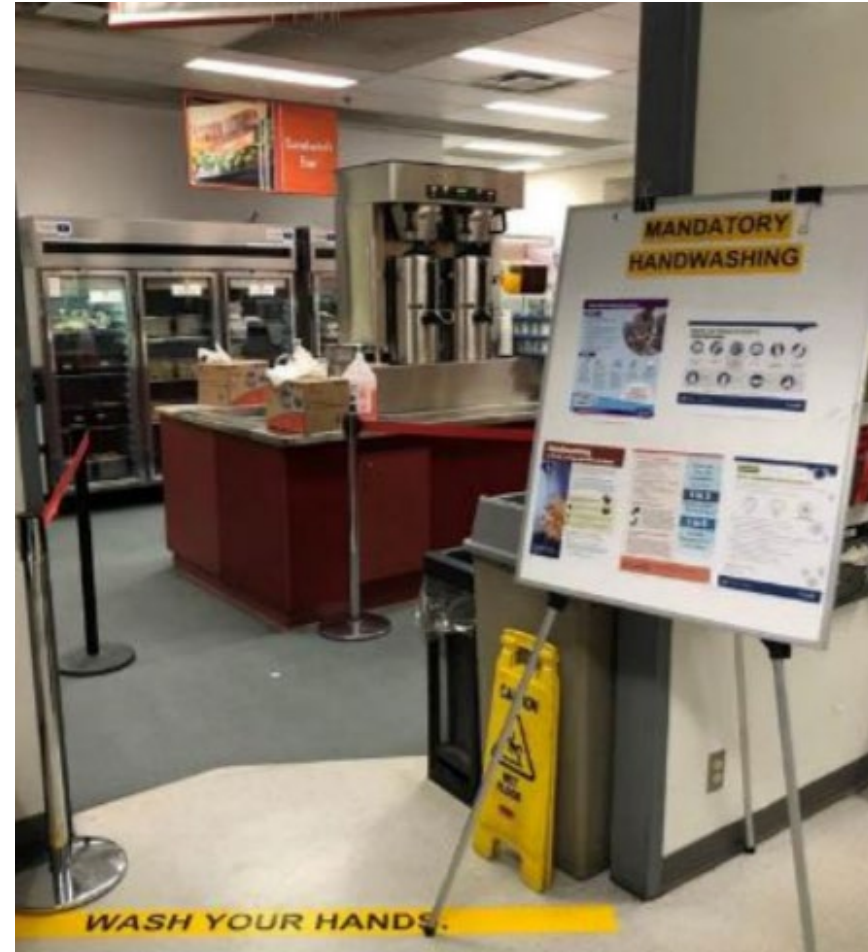


- 60 employees on furlough expected to be back to work in early December based on sequence of work that is needed to get operations up and running.
- Work with ad hoc group is ongoing to complete purchase of Ekati.
- Dominion in creditor protection until December 15, 2020.
- Upcoming court date December 11, 2020.
- Reasonable to expect there to be assignment or transfer process of the company assets at some point should there be another successful purchaser. To be confirmed.
- Water Licence renewal to term application to be submitted to the WLWB. Request for another 26 months (will move expiration date to October 2023).
- Water Licence and other compliance related activities/reporting will continue to be met.

## Recent Changes at Ekati Due to COVID-19

There have been several changes implemented in response to COVID-19.

- Mandatory mask use at Ekati.
- Social distancing changes during work and off shift in the kitchen, lounges, gym and meeting rooms.
- Enhanced cleaning and disinfecting
- Ekati rotation change from 2x2 to 3x3 to extend work cohort and full rotation change.
- COVID-19 testing at Ekati in progress and interim pre-screening testing for staff coming from southern Canada (saliva-based PCR test)
- Flight schedule moved to Wednesday in December to reduce operational delays and improved recovery plan from weather/mechanical delays going forward
- Corporate office work rotation changes with a one week work from home, one week in the office
