





ONGOING REVIEWS

Water Licence Renewal

- Responses to comments submitted on January 19th
- Arctic Canadian appreciates IEMA's thorough review
- Preparations underway for Technical Sessions in late March

Wildlife Management and Monitoring Plan

- Arctic Canadian hosted workshop on February 3rd in Yellowknife
- Conducted follow-up meeting with stakeholders
- Arctic will receive final comments on February 17th
- Arctic to provide final comment responses and submission by March 10th
- Completion of Telemetry Project (Stage 1 expected in Q1)
 - Results inform review of caribou-related migrations and monitoring at site

Interim Closure and Reclamation Plan v 3.1

- Submitted to the WLWB December 23, 2022
- WLWB completing conformity check before posting for public review
- WLWB has saved May 1st 5th window as a time for the Ekati Closure Workshop –
 presumably to clarify comments from parties on the ICRP before they are posted on the
 ORS
- Workshop estimated to be 1-2 days during the May 1st 5th window
