# Work Plan and Core Budget 2007-2009

- Core budget is fixed by the Resolution Agreement and grows with cost of living increases
- Portion of core funding from BHPB goes into a Separate Fund for Agency participation in regulatory and other legal processes
- Additional funding can be requested
- Agency has independence over work plan, not subject to BHPB or government approval
- 2007-8 and 2008-9 work plan and budget prepared based on Agency mandate

### **Technical Focus for Next Two Years**

- Closure and Reclamation
  - Working Group
  - Draft Interim Closure and Reclamation Plan
  - Public Hearing on the Plan
- New Water Licence Requirements
  - Adaptive Management Plan
- Sable, Pigeon and Beartooth Water Licence
- Regional Monitoring and Cumulative Effects
  - Cumulative Effects Study on Lac de Gras
  - Bathurst caribou herd cumulative effects workshop

## **Board Meetings**

- Primary avenue for meeting our mandate
- 5 or 6 per year, plus conference calls
- Agency proposes one board meeting a year be held in a community
- Meetings are open to all society members
- Agency now has a full complement of Directors

#### **Review of Documents**

- Agency regularly reviews documents on:
  - Wildlife
  - Aquatics (including special reports, e.g. Panda Diversion Channel)
  - Air Quality
  - Annual Environmental Reports

### **Separate Fund Activities**

- Relates to Agency interventions in regulatory and other legal processes:
  - Wek'eezhi Land and Water Board Working Group and review of the Interim Closure and Reclamation Plan
  - Sable, Pigeon and Beartooth Water Licence
  - Revised Wastewater and Kimberlite Management Plan
  - Adaptive Management Plan
  - Five-year Review of the Environmental Agreement

#### **Interventions at Public Hearings**

- For 2007-8, the Agency anticipates no public hearings
- For 2008-9, two public hearings are anticipated
  - Interim Closure and Reclamation Plan
  - Sable, Pigeon and Beartooth water licence renewal

#### **Consultation and Communications**

- Agency has maintained its activities
- Annual Report, new Website
- Our policy is to visit communities only on invitation everyone is very busy
- Propose to host the environmental workshop in the years that BHPB does not (conditional on need and availability of information)

#### **Outside Contracts**

- Agency uses outside expertise on occasion for topics like:
  - Closure and Reclamation
  - Air quality
  - Seepage and waste rock management
  - Aquatics
