Re: Proposed Changes to the Ekati Environmental Agreement

Canada and the Government of the Northwest Territories (GNWT) have sent the attached correspondence to the Independent Environmental Monitoring Agency. Canada and the GNWT are proposing changes to the 1997 Ekati Environmental Agreement they believe are consistent with devolution of lands, waters and resources to the GNWT on April 1, 2014. The proposed changes would result in the withdrawal of Canada as a party or signatory to the Agreement.

The Agency is in the process of obtaining further advice on the proposed changes. In the meantime, and as part of our mandate to effectively disseminate information on the Ekati Diamond Mine, we provide you with this correspondence. We have also attached the Agency's letters of March 17 and 28, 2014 when proposed changes to the Ekati Environmental Agreement were previously under consideration. Letters received from the Yellowknives Dene First Nation, Lutsel K'e Dene First Nation and Tlicho Government on the same subject are also attached for your information.

Should your governments have any views on the proposed changes, we would advise that you write directly to the signatories (Government of Canada, Government of the NWT and Dominion Diamond Ekati Corporation). It would be helpful if all the Society members and the Agency were copied on such correspondence.
