Re: Postponement of Hearing on BHP Billiton Motion

On Wednesday May 13, 2009 BHP Billiton Diamonds Inc. submitted the following motion (the Motion) to the Wek'èezhìi Land and Water Board (the Board), requesting a ruling:

"Whether the Wek'èezhìi Land and Water Board, in the context of BHP Billiton Diamond Inc.'s obligations relating to closure and reclamation of the EKATI Diamond Mine, has the jurisdiction to require that BHP Billiton Diamond Inc. establish and maintain fish or fish habitat in the closed pit lakes or the Long Lake Containment Facility at the EKATI Diamond Mine."

On May 15, 2009, the Board issued a letter outlining a process for the review of the Motion which required parties to respond by May 29, 2009 with oral presentations to be heard on June 19, 2009. However, on May 21, 2009, the Board received a request from the Independent Environmental Monitoring Agency (IEMA) to extend the response deadline. On May 25, 2009, the Department of Justice Canada, on behalf of the federal government, submitted a letter to the Board supporting IEMA's request. Both letters are attached.

The Board has decided grant an extension in order to ensure that all parties can prepare fully on this important issue.

The Public Hearing to hear argument on the Motion, currently scheduled for June 19, 2009, is therefore postponed and new dates for this process are given below. The Public Hearing on the Interim Closure and Reclamation Plan (ICRP), currently scheduled for July 15, 2009, has also been postponed but no new date has been set.

The Board is setting the following deadlines to allow for the consideration of the Motion. More information on the format for the July 15, 2009 hearing is forthcoming.
