## **Purpose/Report Summary**

The purpose of this report is to present information to the Board regarding BHPB's request for exemption from preliminary screening for the renewal of their Class "A" Water License MV2001L2-0008, and Land Use Permits MV2001F0032, MV2001X0071 and MV2001X0072.

# **Background / Discussion**

On April 2<sup>nd</sup>, 2008, the WLWB received BHP Billiton's renewal applications for their Sable, Pigeon and Beartooth Water License; MV2001L2-0008, and land use permits; MV2001X-0071, MV2001X-0072 and MV2001F-0032. Board Staff deemed the land use permit applications complete and have sent off the required notification to BHPB and reviewers and also informed parties that the Board has decided that pursuant to section 22(2)(b) of the Mackenzie Valley Land Use Regulations that further studies and/or a hearing are required.

A section of BHPB's renewal application included a request for an exemption from preliminary screening pursuant to Schedule 1 (section 2), Part 1, Paragraph 2 of the Exemption List Regulations made pursuant to subsection 143(1) of the MVRMA.

An exemption from preliminary screening is applicable if: A development, or a part thereof, for which renewal of a permit, licence or authorization is requested that:

- a) Has not been modified; and
- b) Has fulfilled the requirements of the environmental assessment process established by the MVRMA, CEAA or the Environmental Assessment Review Process Guidelines Order.

Comments on BHPB's requested exemption from Preliminary Screening were requested from reviewers by May 16<sup>th</sup>. No comments were received from any reviewers, although several parties did contact Board Staff to clarify BHP's request and LKDFN did send in correspondence indicating that they had no concerns as long as the development hadn't been modified (please find attached). Subsequently, there is no comment table regarding the issue of preliminary screening exemption.

#### Recommendation

Board Staff reviewed BHP Billiton's Sable, Pigeon and Beartooth renewal application and found no change from the original project description. Therefore, based on the lack of concern from reviewers and BHPB's justification outlined in their "Request for Exemption", Board Staff recommend the approval for BHPB's request for exemption from Preliminary Screening.
