On Wednesday May 13, 2009 BHP Billiton Diamonds Inc. submitted the following motion (the Motion) to the Wek'èezhìi Land and Water Board (the Board), requesting a ruling:

"Whether the Wek'èezhìi Land and Water Board, in the context of BHP Billiton Diamond Inc.'s obligations relating to closure and reclamation of the EKATI Diamond Mine, has the jurisdiction to require that BHP Billiton Diamond Inc. establish and maintain fish or fish habitat in the closed pit lakes or the Long Lake Containment Facility at the EKATI Diamond Mine."

A copy of the Motion is attached to this letter.

BHP Billiton has requested the Board rule on the Motion prior to hearing interventions or providing further direction on issues relating to the review of BHP Billiton's Interim Closure and Reclamation Plan for the EKATI Diamond Mine (ICRP).

To allow oral presentation to the Board on the Motion, the Board will also hold a public hearing. The Board will rule on the Motion prior to the continuation of the ICRP Public Hearing.
