Subject: Board staff's response to review comments on Section 2 of the ICRP (MV2003L2-0013)

To the Members of the Ekati ICRP Working Group:

Attached is a letter and filtered comment table prepared by Board staff in response to review comments on Section 2 of the ICRP (signed originals have been placed on the registry). **Please note the deadline contained in the letter as it applies to all members of the Working Group, including BHPB.**

The next step in the ICRP process is for BHPB to prepare a comprehensive comment summary table that contains their responses to all Section 1 review comments that apply to Section 2 and Section 2 review comments. **The deadline for BHPB's response is September 14, 2007.** BHPB's responses will be forwarded to all members who then must review them to determine whether or not BHPB satisfactorily addressed their comments. This review is in preparation for the Working Group meeting that is scheduled for September 28, 2007.

Also attached are Steve Wilbur's review comments on Section 2 that BHPB must respond to in addition to the review comments distributed yesterday. Steve Wilbur is from Jacques Whitford and is the Board's technical consultant for the ICRP.

An additional letter is being prepared in response to review comments on consultation and will be distributed soon.
